**NON-INFECTIOUS/NON-MEDICAL WASTE CERTIFICATION**

**Tradebe will not receive the following kinds of waste (including the generator's state's equivalent).**

**40 CFR 60.51c**

"Infectious Agent means any organism (such as a virus or bacteria) that is capable of being communicated by invasion and multiplication in body tissues and capable of causing disease or adverse health impacts on humans."

**29 CFR 1910.1030**

"Other Potentially Infectious Material", means human body fluids: human secretions, blood, cerebrospinal fluid, synovial fluid, pleural fluid, pericardial fluid, peritoneal fluid, amniotic fluid, saliva in dental procedures, any body fluid that is visibly contaminated with blood, and all body fluids in situations where it is difficult or impossible to differentiate between body fluids; (2) Any unfixed tissue or organ (other than intact skin) from a human (living or dead); and (3) HIV-containing cell or tissue cultures, organ cultures, and HIV- or HBV-containing culture medium or other solutions; and blood, organs, or other tissues from experimental animals infected with HIV or HBV."

**INDIANA Administrative Code**

410 IAC 1-3-10 "Infectious waste", means waste that epidemiologic evidence indicates is capable of transmitting a dangerous communicable disease. The term includes, but is not limited to the following:

- (1) Contaminated sharps or contaminated objects that could potentially become contaminated sharps.
- (2) Infectious biological cultures, infectious associated biologicals, and infectious agent stock.
- (3) Pathological waste.
- (4) Blood and blood products in liquid and semi liquid form.
- (5) Carcasses, body parts, blood and body fluids in liquid and semi liquid form, and bedding of laboratory animals.
- (6) Other waste that has been intermingled with infectious waste.

The information in this document is not by any means a complete representation of EPA's or State's regulations or policies regarding infectious waste. Each State or Regional Office may vary therefore please contact your Region or State for additional information.
